- The authorized person shall not rent, lend, sell, transfer or otherwise transport the biomedical waste without obtaining prior permission of the prescribed authority.

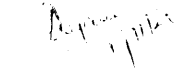

8. It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility, and such other terms and conditions may be stipulated by the prescribed authority.
9. Applicant shall comply with Standards for Treatment and Disposal of Bio-Medical Wastes prescribed in Schedule-II of the Bio-Medical Waste Management Rules, 2016.
10. HCF shall strictly obey The Bio Medical Waste management Rules 2016 and amendment thereof.
11. HCF shall install STP for the treatment of generated domestic wastewater and inform the Board accordingly.
12. Membership Certificate of CBWTF shall be renewed time to time.
13. HCF shall provide Effluent Treatment Facility for the treatment of generated wastewater if discharge from HCF is connected with City's Town's public sewerage network not having any terminal sewage treatment plant or if the HCF is not connected to public sewerage network.
14. The treated wastewater from healthcare facility should conform to the standard of liquid waste as listed in schedule II of BMW Rules, 2016
15. Used oil generated from D.G set shall disposed off as per the provision of Hazardous waste management rules, 2016 and amendment rules thereof
